AGREED ORDER

Parties

WHEREAS, the parties to the Agreed Order herein are the Kentucky Board of Speech-Language Pathology and Audiology, hereinafter referred to as the "Board," and Susan Boyer hereinafter referred to as the "Respondent."

Jurisdiction

WHEREAS, the Board has jurisdiction over this matter pursuant to KRS Chapter 334A and the related administrative regulations.

History

WHEREAS, the Respondent failed to make timely payment of her 2009-2010 renewal fee due to a check returned due to insufficient funds; **WHEREAS**, by her letter of January 8, 2010, the Respondent indicated her wish to resolve this action informally without a hearing held pursuant to KRS 13B;

WHEREAS, the parties mutually desire to settle the issues in an expeditious manner, without the need for a formal hearing.

Terms of Agreement

THEREFORE, it is hereby agreed between the undersigned parties that this matter shall be settled and resolved upon the following terms:

- 1) The Respondent shall carefully review the Agreed Order herein and enters into this Agreed Order knowingly, willingly and voluntarily and after having reviewed the due process rights afforded to her under KRS Chapter 334A and the accompanying regulations;
- 2) The Respondent, Susan Boyer, acknowledges that the Board has accused her of violations of KRS 334A.180(1)(a). The Respondent admits violation of that provision;
- 3) The Respondent, Susan Boyer, shall pay to the Board a fine in the sum of \$500. Payment of the fine shall be made by sending a certified check or money order made payable to the Kentucky Board of Speech-Language Pathology and Audiology to the Board Office such that it is received prior to April 1, 2010;

Complete Agreement

This Settlement Agreement consists of four pages, inclusive of the certificate of service, and embodies the entire agreement between Kentucky Board of Speech-Language Pathology and Audiology and the Respondent, Susan Boyer. It may not be altered, amended or modified without the express written consent of both parties.

Publication of Settlement Agreement

The Respondent acknowledges that, once adopted by the Board, this Agreed Order may be considered a public document, available for inspection at any time by any member of the public under the Kentucky Open Records Act, and may be reportable under federal law.

Voluntary Waiver of Rights

The Respondent, Susan Boyer, has had the opportunity at all times to seek advice from competent counsel of choice. No coercion has been exerted upon the Respondent, nor have any promises been made other than those reflected in this Agreed Order. Respondent agrees to waive her right to appeal from this Order to the Circuit Court.

4) Respondent acknowledges that a check returned for insufficient funds shall constitute noncompliance with this agreement. In the event that a check is returned for insufficient funds, the Board may proceed with an administrative hearing on this matter pursuant to the procedures and processes outlined in KRS 13B;

5) This agreement shall constitute the final resolution of the violation committed by the Respondent and referenced in the "History" subsection of this agreement.
