**Call to Order**

Chair Ann Olson called the meeting to order at 1:10 p.m.

**Old Business**

The Board met and reviewed audited renewals. Deanna Frazier made a motion to approve the renewals reviewed by the Board. George Purvis seconded the motion. The motion carried unanimously.

The Board discussed an e-mail from Heather Elza where she had received a Cease and Desist letter for non-renewal for January 31, 2012. Ms. Olson will contact KSHA to get the number of copies needed and the date they are

needed by. Marcia Egbert will have copies ready by the next Board meeting. Deanna Frazier asked that Ms. Egbert make an additional 75 copies so that she can distribute them to those that attend the Kentucky Audiology Association conference.

Ms. Olson asked Ms. Egbert to add, "Update on Ethics CEU Criteria" to the agenda for the meeting on February 1, 2013.

Ms. Olson asked Ms. Egbert to have the display board ready at the next meeting so they can take it to the KSHA Conference.

Ms. Olson drafted an e-mail to be sent to those that have not renewed after entering those received in the mail on Monday. Ms. Egbert will see if we can create the group e-mail. If not, she will do a letter and send it out on Monday.
