#### Call to Order

Margaret Adkins called the meeting to order at 1:02 p.m.

### Consent Agenda - Minutes and Monthly Financial Report

The May 13, 2025, Board meeting minutes were presented for the Board's review. Tamara Cranfill motioned to approve the minutes. Ciera Sherwood seconded the motion, and the motion carried.

Kristen Lawson provided the DPL report. It was reported that Jamar Carter is no longer with the agency and that April Alsabrook will be filling as the temporary administrative supervisor.

#### **Board Attorney's Report**

Tamara Cranfill attended the June 18, 2025, regulation meeting in Covington on behalf of the Board. The Compact rule 201 KAR 17:120 ASLP went into effect on June 18, 2025.

201 KAR 17:120 and 201 KAR 17:120E was presented for Board review for filing an amendment to the regulation. The amendment is in regard to the rule passed by the Commission for the ASLP-IC fee. A motion was made by Tamara Cranfill to approve Board Counsel filing 201 KAR 17:120 and 201 KAR 17:120E to include the rule on fees by the compact and file on behalf of the Board by August 29, 2025. Margaret Adkins seconded the motion and the motion carried.

The Board discussed the ASLP-IC FBI Background check requirement. The Board is going to inquire with state associations to assist with FBI Background check legislation. Tamara Cranfill moved to assign the criminal background legislation discussion/recommendation to the regulations committee meetings. Jennifer Lutes seconded the motion, and the motion carried. The Regulation Committee to meet on August 12, 2025, and it's the committees goal to have a recommendation for the Board at the September 9, 2025, meeting.

#### **Old Business**

A motion was made by Tamara Cranfill for the Regulations Committee to examine the state fee for the ASLP-IC. Margaret Adkins seconded the motion, and the motion carried. The Board decided that the state fee for audiologists and speech language pathologists will be the same. The Board Specialist will follow up with ASLP-IC on its fee survey and will refer Compact Connect survey questions to COT.

#### **New Business**

An update was provided on the CMS Medicare Part B policy from Tamara Cranfill and Susan Adams. The Board is unable to act in an advisory role but will keep tabs on how it will proceed. Keep CMS Medicare Part B on Old Business going forward so the Board can continue to discuss.

- 2025-SLP-00003: Request the licensee to appear virtually before the Complaints Committee at its August 12, 2025, meeting and show cause why the Board should not file a formal administrative complaint to suspend her license for failure to respond to the complaint and/or complete her requirements for licensure.
- 2024-AUD-00002: Referred to Clinton Investigations in June. Tabled until report received from Clinton Investigations.
- A.J. CEU Verification: Approve the 8 virtual CEU hours submitted for compliance verification and allow the licensee to complete the final 2 CEU hours in any format.

Complaints Committee motioned to accept the committee's recommendations for 2025-SLP-00002, 2025-SLP-00003, and A.J. CEU verification. Ciera Sherwood seconded the motion, and the motion carried.
