Call to Order

Jennifer Lutes called the meeting to order at 1:00 p.m.

Consent Agenda - Minutes and Monthly Financial Report

- Board Counsel filed the Boards proposed emergency administrative regulation, 201 KAR 17:120E ASLP and ordinary administrative regulation, 201 KAR 17:120 ASLP, with the Legislative Research Commission on November 26, 2024.
- Notices of the proposed administrative regulations were posted to the Board website.

- The public hearing date and public comment period end date for each proposed regulation was reported to the Board.
- The Administrative Regulation Review Subcommittee (ARRS) is scheduled for February 11, 2025, at 1:00 p.m., and March 25, 2025, at 1:00 p.m. Jennifer Lutes volunteered to accompany Board Counsel, Sara Janes, to the in-person ARRS meetings at the Capital Annex, on the above date. The Board agreed to Jennifer Lutes appointment.

- 2024-SLP-00005: Informal Settlement offer to pay a \$250 fine and complete 2 CEU hours related to supervision requirements and provide verification within 90 days. Board Counsel to draft the agreed order for licensure review. Follow up correspondence to be completed by the Administrative Specialist Senior.
- 2024-AUD-00002: Board initiated complaint against licensee A.H. for violation of section 1 of 201 KAR 17:041. Board Counsel to draft the Board complaint. Follow up correspondence to be completed by the Administrative Specialist Senior.

Jennifer Lutes made a motion to approve the complaint committee recommendation for 2024-SLP-00004, 2024-SLP-00005, and 2024-AUD-00002. Tamara Cranfill seconded the motion and the motion carried.
