Ms. Vick provided an update on the scanning project. At this time more than half of all SLP-A files have been scanned into the licensing system database. The Board originally voted to provide \$20,000 toward this project of which \$16,000 has been spent. Ms. Vick does not feel this is enough to complete the project and requests the Board provide \$10,000 more. Ms. Driscoll made a motion to provide additional funds, seconded by Dr. Bush and it carried.

New Business

Ms. Norton brought to the attention of the Board the Interim Speech-Language Pathology license application fails to advise the potential licensee the necessity of submitting an official transcript from their University. Mr. Kerr advised it would be best to wait until the Board has more regulation changes to submit to update.
