#### Consent Agenda - Minutes and Monthly Financial Report

#### **DPL Report**

Mr. Winstead advised a special legislative session was held last week to address the states response to COVID-19. He advised House Joint Resolution 1 was passed effectively extending the declared state of emergency until Jan 15, 2022. He advised this would keep in place HB150 which states no professional licenses can expire during the declared state of emergency.

He also advised again members may continue to attend meetings via teleconference or in person. He advised masks are still required inside Executive Branch office buildings.

## **Board Attorney's Report**

Ms. Boggs advised her and Commissioner Winstead had reviewed KRS 211.336, a telehealth law that took effect in June. This states that a state agency shall not require a provider to be physically present with a patient unless medically necessary. She advised the Board would need to change their regulation to adopt this but to begin thinking about any situations that could be deemed as medically necessary.

Ms. Bradford advised the tracking sheet is up to date.

#### **New Business**

Ms. Bradford presented potential meeting dates for 2022. She advised there are no issues outside of November. The second Tuesday of November falls on Election Day. After discussion, members will review their schedules and review at the next meeting.

Ms. Adkins asked Ms. Boggs the process on adding wording to the Interim Licensure Application to advise potential licensees of the requirement to submit an official transcript. Ms. Boggs advised in order to change the form, the Board would have to submit a regulation change of the regulation the form is incorporated in. She advised since the Board is already submitting regulation changes to update the telehealth regulation, this could be done at the same time. Ms. Bradford will prepare proposed form changes and submit to Ms. Boggs.
