Call to Order

Chair Ann Olson called the meeting to order at 1:25 p.m.

Election of Officers

Deanna Frazier made a motion to nominate Anne Olson for Chair and Heather Johnson as Vice-Chair for the Speech-Language Pathology and Audiology Board. Richard Dressler seconded the nomination. The nomination passed unanimously.

Minutes

A motion was made by Heather Johnson to approve the minutes of December 4, 2012 as written. The motion was seconded by Richard Dressler. Motion carried.

Board Monthly Financial Report

The Financial Report for July 1, 2012 through December 31, 2012 was reviewed. No action taken.

Licensure Status Report

The Licensure Status Report was discussed. Marcia Egbert reported that she discussed the random audit selection again with Wendy Tucker, the IT person for O & P. Ms. Tucker did a query and there were approximately 1,121 renewals expiring 1/31/2013. She stated again that the audit is totally random; however, by auditing 15% of SLP's expiring in January 2013, that totals 168 licensees that will be audited which gives you about a one in six chance of getting audited. Those odds are pretty high, so it is conceivable that someone could get picked 3 times in a row. No further action was taken.

O & P Report

Marcia Egbert reported the following:

- Administrative Specialist Board Administrator Tony Crockett has accepted a new position. O & P is in the process of filling this vacancy.
- The Office of the Attorney General will conduct Open Records training on Friday, January 11, 2013 for all Board Administrators. They are also willing to do Open Meetings training for Board members if there is enough interest.
- The IT staff is working closely with the Commonwealth Office of Technology (COT) to rewrite the database application. COT has assigned a new Business Analyst to rewrite the database application.
- Legislative Session Literature Resources are available. They can be picked up in Courtney Bourne's office.

Attorney's Report

Michael West submitted the Statement of Consideration to LRC with the changes discussed at the previous Board meeting. Mr. West stated that it passed through LRC without any problems and should be in effect within the next 30-60 days.

Old Business

Richard Dressler did not draft a response letter to Tracy Wilson in regard to SLP vs. OT – Scope of practice in treatment of dysphagia communication related deficits and cognition but will do so this week and send it to Marcia Egbert to respond to Ms. Wilson.

The Board reviewed a response to an e-mail from Mollie Thurman in regard to renewal notices and when they were sent out. No further action taken.

The Board reviewed a response to an e-mail from Leigh Roark in regard to Interpretation about RTI for SLP's and caseloads. No further action taken.

A regulation change regarding the requirement of Ethics in continuing education was discussed. Anne Olson and Deanna Frazier will gather available providers of ethics trainings (including a presentation that will be given at the KSHA Conference) and Ms. Olson will then draft a letter with all regulation changes and information on the availability of trainings for SLP's and AUD's. The letter will be mailed to all licensees by early February and will also be posted on the website. Ms. Egbert voiced concern on the ability of getting a mass mailing out during renewals and felt that it wasn't something that she would be capable of doing within the timeframe discussed. Ms. Olson asked if it were possible for some of her interns to volunteer to stuff and label the letters. Ms. Egbert will contact Executive Director Bourne to see if this is an option and report back to the Board.

The discussion of social media as a way to get information out to the licensees followed. Ms. Egbert stated that the IT at O & P has said that we can do group e-mails as a means of contact but they were unsure of the feasibility of having a Facebook account. No further action taken.

The Board continues to monitor goals and timelines of the Strategic Plan, Archive Issues and Frequently Asked Questions and tabled discussion of the status of these issues until the next meeting.

New Business

Exhibitor Confirmation and times for manning the exhibit at the KSHA Convention was discussed. Both Anne Olson and Heather Johnson plan to attend and will cover the booth on February 28th and 29th. They requested that we have copies of the new regulation changes on Ethics and Telehealth to hand out.

George Purvis asked the Board for approval for travel and per diem for him to attend the 2013 annual conference of the National Council of State Boards of Examiners for Speech-Language Pathology and Audiology in San Antonio in October as a director. Heather Johnson so moved. Richard Dressler seconded the motion. The motion was approved unanimously.

The Citizen Advocacy Center newsletter was made available for review.

Anne Olson asked Marcia Egbert if there was a possibility that she could create an electronic calendar for the Board so that we can track dates for mailings and information pertaining to the Board. Ms. Egbert stated that she keeps a hard copy calendar of all SLP/A dates/meetings/etc. and is willing to create an electronic calendar as time permits.
